
NEW HOTEL AND CONVENTION CENTER AT MARYLAND LIVE

The Coridsh Company, developers of the Maryland Live Casino, plan to develop an eighteen (18) story, three hundred (300) person capacity luxury hotel and conference center at the Arundel Mills. This hotel is designed to house the high rollers using the casino.

The conference center addition to the plan, will run concurrently through planning and zoning along with the hotel so building can take place at the same time. The 30,000-40,000 square foot conference center will hold 4,000 people. County Executive, Steve Schuh hopes the business this hotel and conference center brings to the area will benefit the surrounding businesses.

The road surrounding the mall will be expanded near the casino to accommodate the new structure and better the flow of traffic around the mall.

FREE SPAYING OR NEUTERING FOR PET CATS AND DOGS



Sunshine's Friends Cat Rescue and Sanctuary (SFCRS) is offering **FREE** spaying or neutering for up to 100 pet cats and 50 dogs for Jessup residents! Full funding for this project was provided by the Maryland Department of Agriculture, Spay and Neuter Grants Program. The program starts on 01 November and runs until the quotas are met. SFCRS has partnered with Spay Now Animal Surgery Clinic in Laurel to perform the operations.

The program covers all the costs for spaying or neutering plus a rabies shot. Also, for only \$5.00, Spay Now will treat your pet with Revolution, which kills fleas, ticks, worms, and ear-mites.

Proof of Jessup residency (i.e. driver's license) is all that is required. If you are unable to take your pet to Spay Now yourself, Sunshine's Friends can provide transportation to and from the vet with at least one week's advance notice.

WHAT IS THE LOCAL DEVELOPMENT COUNCIL and HOW DOES THIS AFFECT ME?

The Local Development Council (LDC) is a board comprised of the Senator from District 32, Two Delegates from District 32, one representative of the video lottery operation licensee from the Cordish Company, seven residents of the communities surrounding the casino and four representatives of local business or institutions in the immediate proximity to the casino.

The LDC is responsible for advising the County Executive on the needs and priorities of the communities directly surrounding the Maryland Live Casino. A portion of the total revenue generated by the video lottery terminals (4.51%) are then distributed by the LDC. Communities in the immediate vicinity (3 mile radius) of the casino will benefit from this money which can be applied for by local grants.

Some organizations granted money for 2016 are: Meade High School Parents Teacher Student Association received \$39,996; Severn Crest Home Owners Association received \$35,690; the Villages of Dorchester Home Owners Association received \$40,000; and the National Electronics Museum received \$25,000. A total of \$250,000 was awarded in 2016.

The Jessup Improvement Association is planning apply for the next grant application process. We hope to fulfill our wish list of improvements for the community hall that serves the Jessup and Hanover communities.

DID YOU KNOW?

The community of Jessup got its name from an engineer with the Baltimore and Ohio Railroad during its original construction. Mr. Jessup was charged with making sure the rail track was properly laid through a particularly difficult two mile stretch. Once completed, this stretch was called the "Jessup's Cut." As the town grew in the vicinity with the influence of the railroad the name "Jessup" stuck.

TAX DEDUCTABLE OR NOT?

The Jessup Improvement Association recently refiled for its nonprofit tax status after learning our 501C4 status was revoked for failing to file the necessary paper work for the years 2012 and 2013. Treasurer Hoffman learning this paper work needed to be filed sent the 2014 filing five days late. The IRS seeing the 2012 and 2013 years were missing revoked our status. This led to a thought. Should JIA be a 501C3 or C4 and what is the difference?

A cursory internet search listed the primary difference is the ability of a 501C4 to support or lobby for a political purpose but the organization must spend less than 10 % of its operating budget on this endeavor. However, donations to a 501C4 are **not** tax deductible. Examples of 501C4 groups are those that promote social welfare like civil leagues and Lions Clubs.

501C3 organizations are nonprofit groups that promote religious, scientific, charitable, or literary

purposes. Examples of 501C3 are churches, youth groups, museums, and private operating foundations. Donations to a 501C3 **are** tax deductible for the donor and the organization must receive at least 1/3 of its donated money from a broad base of public support. Support or endorsement of a political candidate is strictly prohibited.

TURKEY SAFETY

Thanksgiving is just around the corner and food safety is a major concern. The CDC recommends being aware of 4 issues; Thaw, Prepare, Stuff, and Cook. The following is directly from the CDC website:

Safe Thawing

Thawing turkeys must be kept at a safe temperature. The "danger zone" is between 40 and 140°F — the temperature range where foodborne bacteria multiply rapidly. While frozen, a turkey is safe indefinitely, but as soon as it begins to thaw, bacteria that may have been present before freezing can begin to grow again, if it is in the "danger zone."

There are three safe ways to thaw food: in the refrigerator, in cold water, and in a microwave oven.

Safe Preparation

Bacteria present on raw poultry can contaminate your hands, utensils, and work surfaces as you prepare the turkey. If these areas are not

cleaned thoroughly before working with other foods, bacteria from the raw poultry can then be transferred to other foods. After working with raw poultry, always wash your hands, utensils, and work surfaces before they touch other foods.

Safe Stuffing

For optimal safety and uniform doneness, cook the stuffing outside the turkey in a casserole dish. However, if you place stuffing inside the turkey, do so just before cooking, and use a food thermometer. Make sure the center of the stuffing reaches a safe minimum internal temperature of 165°F. Bacteria can survive in stuffing that has not reached 165°F, possibly resulting in foodborne illness.

Safe Cooking

Set the oven temperature no lower than 325°F and be sure the turkey is completely thawed. Place turkey breastside up on a flat wire rack in a shallow roasting pan 2 to 2-1/2 inches deep. Check the internal temperature at the center of the stuffing and meaty portion of the breast, thigh, and wing joint using a food thermometer. Cooking times will vary. The food thermometer must reach a safe minimum internal temperature of 165°F. Let the turkey stand 20 minutes before removing all stuffing from the cavity and carving the meat.

R2 UPDATE

It has been over one year since we have gone to the hearings to prevent Koch Homes from rezoning property they purchased from R1 (one home per acre) to R2 (2.5 homes per acre.) To recap Koch Homes applied to the zoning board and was denied their request. They appealed to the Board of Appeals and won. We filed to object and the case went to the Circuit Court where once again Koch Homes prevailed. We have appealed this decision to the Special Circuit Court of Appeals. At this point Koch Homes is able to begin work on their project but it is at their own risk should we prevail.

The courts have now asked both parties to agree to an Alternative Dispute Resolution to try and come to an agreement before going before the judge. Our lawyer, Tom Deming, was surprised that Koch Homes has agreed to this step and feels they may have something to offer. The date for this is mediation of sorts is set for Wednesday, Oct. 28th.

The lawsuit with GJCO has been settled but JIA continues to be the center of other legal action. Due to our concerns regarding the financial burden on JIA the board has agreed to hire Ryan Kennedy as the lawyer to represent us in place of Tom Deming should the case continue after the Alternative Dispute Resolution. Mr. Kenned was referred through the Community Law Center and will provide his services Pro Bono. JIA will still be responsible for other costs such as filing fees, copies, and transcripts.
